1. Purpose

This standard operating procedure (SOP) describes the use and maintenance of 'Defibrillator' as basic life support.

2. Scope

This SOP is limited to describing procedures to use and maintain 'Defibrillator'.

3. Responsibilities

Principal investigator, Co-investigator, or any other medically qualified staff in the team, as delegated by the PI, will be responsible for use and maintenance of 'Defibrillator'.

4. Detailed Instructions

• Approach to participant

- > The investigator or the delegated person will refer to the protocol to ensure specific requirements of defibrillator in patients.
- > The investigator or the delegated person will explain the procedure to the patient attendant prior to use
- > The investigator or the delegated person should wash their hands before they use
- Equipment Set-up
- The designee should assemble and check that all parts of the equipment functions properly.
- > The designee should connect power charger to unit (port on the side of unit) and to electrical outlet.

• Equipment uses

- > Sufficient gel should be applied on both paddles
- Appropriate energy should be selected by using the energy selector knob

- ➤ The equipment should be charged using CHARGE button on unit or charge button on APEX paddle.
- > Wait for charging complete tone.
- > Defibrillator checks the rhythm and if shockable rhythm is seen then only defibrillator shock to be given
- > The Anterior-Apex scheme of positioning of the paddles is used as it monitors the ECG and based on the type of rhythm the use of defibrillation can be decided.
- \gt The right Paddle should be placed below right clavicle on the chest while left paddle is placed in the anterior axillary line in 9 10th Intercostal area and SHOCK button should be held down on both paddles or SHOCK button should be pressed on unit
- ➤ Before giving the shock, all the nurses and doctors should not touch the patient and the bed and the doctor giving the shock before should tell "All Clear" before giving shock.
- > Paddles should be placed on the paddle holder.
- ➤ Unit should be charged to 200J. Wait for charging complete tone.
- > Energy should be delivered within 190 J to 210J
- > Operator and bystanders should keep distance and they are not in direct contact with the patients.

Maintenance

- The designee should ensure that that equipment is appropriately cleaned and maintained in good working order.
- > Condition of unit and electrical cord/plug should be inspected regularly to ensure safe operation.
- > Equipment determined to be unsafe will be removed from service immediately.
- The whole unit and all components should be inspected before and after each use for, damage, cracks, looseness, or wear and replace when necessary.
- > Only soft cloth damped with mild detergent should be used for wiping all plastic parts and cables.
- > Do not use alcohol/acetone-based cleaning agents.
- > Paddle plates should be cleaned after every use
- Any additional maintenance/service should be performed by authorized personnel
